#### **Specific Educational Strategies:**

Schedule (hours): procedures occur as a part of clinical experience in the ambulatory (e.g. FMP or sports medicine office) and hospital (e.g. in ED or on L&D) experiences. Faculty assigned to the experience provide supervision including prepping trainee and patient for the experience (e.g. review supply list, watch video or read about technique, provide demonstration, consent process, etc), assist in procedure (providing hands on or verbal instruction), and provide feedback including signing off on the procedure and level of independence within MedHub.

**Teaching Methods & Venues**: adult inpatient, adult and pediatric ED, ICU, FMP, gynecology, sports med/ortho, surgery, electives.

Evaluation Methods and Timing: Residents are to log procedures performed using MedHub within four weeks of performing any procedure. For those rotations where the supervising physician does not have access to TCH MedHub, the resident is to log the procedure in their Procedure Log Book (provided in Orientation) at the time of the procedure. Residents are to record procedure, age and gender of patient, and level of involvement in the procedure. The supervising attending will confirm the procedure, further assigning a level of independence. The three levels of independence is asfollows: Level 1 Knowledge only (knows the indications and contra-indications for the procedure: preceptorhad to provide hands-on assistance); Level 2 Not yet Proficient (Level 1 plus some experience doing the procedure but not enough experience to be proficient: Verbal cues required during procedure); Level 3 Proficient (Levels 1 & 2, plus is able to perform the procedure independently). Residents procedure logs and competencies are reviewed by the residency faculty clinical competence committee and the program director twice yearly. To be certified in a procedure (deemed proficient), the PD will review the MedHub procedure log twice yearly and advance certification based on the number of verified procedures and the level of independence. All procedures have a pre-assigned number required to for competency based upon faculty discussion and review of literature.
